### License Agreement

#### Terms of Use

1. Your relationship with Cetec ERP, Inc.

1.1 Your use of the Cetec Software (referred to as "Cetec" or "Software" in this document) is subject to the terms of a legal agreement between you and Cetec ERP, Inc. "Cetec ERP" means Cetec ERP, Inc., whose principal place of business is at 1700 Montopolis Dr., Ste. E., Austin, TX 78741, United States. This document explains how the agreement is made up, and sets out some of the terms of that agreement.

1.2 Unless otherwise agreed in writing with Cetec ERP, your agreement with Cetec ERP will always include, at a minimum, the terms and conditions set out in this document. These are referred to below as the "Universal Terms."

1.3 Your agreement with Cetec ERP will also include the terms of any Legal Notices applicable to the Software, in addition to the Universal Terms. All of these are referred to below as the "Additional Terms." Where Additional Terms apply to a Service, these will be accessible for you to read either within, or through your use of, that Service.

1.4 The Universal Terms, together with the Additional Terms, form a legally binding agreement between you and Cetec ERP in relation to your use of the Software. It is important that you take the time to read them carefully. Collectively, this legal agreement is referred to below as the "Terms."

1.5 If there is any contradiction between what the Additional Terms say and what the Universal Terms say, then the Additional Terms shall take precedence in relation to that Service.

#### 2. Accepting the Terms

2.1 In order to use Cetec, you must first agree to the Terms. You may not use Cetec if you do not accept the Terms.

2.2 You can accept the Terms by:

(A) clicking to accept or agree to the Terms, where this option is made available to you by Cetec ERP in the user interface for any Software; or

(B) actually using Cetec. In this case, you understand and agree that Cetec ERP will treat your use of Cetec as acceptance of the Terms from that point onwards.

2.3 You may not use Cetec and may not accept the Terms if you are a person barred from receiving the Software under the laws of the United States or other countries including the country in which you are resident or from which you use the Software.

2.4 Before you continue, you should print off or save a local copy of the Terms for your records.

### 3. Language of the Terms

3.1 Where Cetec ERP has provided you with a translation of the English language version of the Terms, then you agree that the translation is provided for your convenience only and that the English language versions of the Terms will govern your relationship with Cetec ERP.

3.2 If there is any contradiction between what the English language version of the Terms says and what a translation says, then the English language version shall take precedence.

### 4. Provision of the Software by Cetec ERP

4.1 Cetec ERP has subsidiaries and affiliated legal entities around the world ("Subsidiaries and Affiliates"). Sometimes, these companies will be providing the Software to you on behalf of Cetec ERP itself. You acknowledge and agree that Subsidiaries and Affiliates will be entitled to provide the Software to you.

4.2 Cetec ERP is constantly innovating in order to provide the best possible experience for its users. You acknowledge and agree that the form and nature of the Software which Cetec ERP provides may change from time to time without prior notice to you.

4.3 As part of this continuing innovation, you acknowledge and agree that Cetec ERP may stop (permanently or temporarily) providing the Software (or any features within the Software) to you or to users generally at Cetec ERP's sole discretion, without prior notice to you. You may stop using the Software at any time. You do not need to specifically inform Cetec ERP when you stop using the Software.

4.4 You acknowledge and agree that if Cetec ERP disables access to your account, you may be prevented from accessing the Software, your account details or any files or other content which is contained in your account.

4.5 You acknowledge and agree that while Cetec ERP may not currently have set a fixed upper limit on the amount of

storage space used for the provision of any Software, such fixed upper limit may be set by Cetec ERP at any time, at Cetec ERP's discretion.

#### 5. Use of the Software by you

5.1 In order to access certain Software, you may be required to provide information about yourself (such as identification or contact details) as part of the registration process for the Software, or as part of your continued use of the Software. You agree that any registration information you give to Cetec ERP will always be accurate, correct and up to date.

5.2 You agree to use the Software only for purposes that are permitted by (a) the Terms and (b) any applicable law, regulation, third-party terms of service, or generally accepted practices or guidelines in the relevant jurisdictions (including any laws regarding the export of data or software to and from the United States or other relevant countries).

5.3 You agree not to access (or attempt to access) any of the Software by any means other than through the interface that is provided by Cetec ERP, unless you have been specifically allowed to do so in a separate agreement with Cetec ERP.

5.4 You agree that you will not engage in any activity that interferes with or disrupts the Software (or the servers and networks which are connected to the Software).

5.5 You agree that if you use Cetec to develop a service for other users, you will protect the privacy and legal rights of those users. If the users provide you with user names, passwords, or other login information or personal information, you must make the users aware that the information will be available to your application, and you must provide legally adequate privacy notice and protection for those users. If your application stores information submitted by users, it must do so securely. If the user provides you with Cetec ERP Account information, you may only use that information to access the user's Cetec ERP Account when, and for the limited purposes for which, the user has given you permission to do so.

5.6 Unless you have been specifically permitted to do so in a separate agreement with Cetec ERP, you agree that you will not reproduce, duplicate, copy, sell, trade or resell the Software for any purpose.

5.7 You agree that you are solely responsible for (and that Cetec ERP has no responsibility to you or to any third party for) any breach of your obligations under the Terms and for the consequences (including any loss or damage which Cetec ERP may suffer) of any such breach.

#### 6. Your passwords and account security

6.1 You agree and understand that you are responsible for maintaining the confidentiality of passwords associated with any account you use to access the Software.

6.2 Accordingly, you agree that you will be solely responsible to Cetec ERP for all activities that occur under your account.

6.3 If you become aware of any unauthorized use of your password or of your account, you agree to notify Cetec ERP immediately.

## 7. Privacy and your personal information

7.1 For information about Cetec ERP's data protection practices, please read Cetec ERP's privacy policy included at [www.cetecerp.com/privacy/](http://www.cetecerp.com/privacy/) This policy explains how Cetec ERP treats your personal information, and protects your privacy, when you use the Software.

7.2 You agree to the use of your data in accordance with Cetec ERP's privacy policies.

## 8. Content in the Software

8.1 You understand that all information (such as data files, written text, computer software, music, audio files or other sounds, photographs, videos or other images) which you may have access to as part of, or through your use of, the Software are the sole responsibility of the person from which such content originated. All such information is referred to below as the "Content."

8.2 You agree that you are solely responsible for (and that Cetec ERP has no responsibility to you or to any third party for) any Content that you create, transmit or display while using the Software and for the consequences of your actions (including any loss or damage which Cetec ERP may suffer) by doing so.

## 9. Proprietary rights

9.1 You acknowledge and agree that Cetec ERP (or Cetec ERP's licensors) own all legal right, title and interest in and to the Software, including any intellectual property rights which subsist in the Software (whether those rights happen to be registered or not, and wherever in the world those rights may exist).

9.3 If you have been given an explicit right to use any of these brand features in a separate written agreement with Cetec ERP, then you agree that your use of such features shall be in compliance with that agreement, any applicable provisions of

the Terms, and Cetec ERP's brand feature use guidelines as updated from time to time.

9.4 Cetec ERP acknowledges and agrees that it obtains no right, title or interest from you (or your licensors) under these Terms in or to any Content that you create, submit, post, transmit or display on, or through, the Software, including any intellectual property rights which subsist in that Content (whether those rights happen to be registered or not, and wherever in the world those rights may exist). Unless you have agreed otherwise in writing with Cetec ERP, you agree that you are responsible for protecting and enforcing those rights and that Cetec ERP has no obligation to do so on your behalf.

9.5 You agree that you shall not remove, obscure, or alter any proprietary rights notices (including copyright and trade mark notices) which may be affixed to or contained within the Software.

9.6 Unless you have been expressly authorized to do so in writing by Cetec ERP, you agree that in using the Software, you will not use any trade mark, service mark, trade name, logo of any company or organization in a way that is likely or intended to cause confusion about the owner or authorized user of such marks, names or logos.

#### 10. License from Cetec ERP

10.1 Cetec ERP gives you a personal, worldwide, royalty-free, non-assignable and non-exclusive license to use the software provided to you by Cetec ERP as part of the non-commercial Software as provided to you by Cetec ERP (referred to as the "Software" below). This license is for the sole purpose of enabling you to use and enjoy the benefit of the Software as provided by Cetec ERP, in the manner permitted by the Terms.

10.2 You may not (and you may not permit anyone else to) copy, modify, create a derivative work of, reverse engineer, decompile or otherwise attempt to extract the source code of the Software or any part thereof, unless this is expressly permitted or required by law, or unless you have been specifically told that you may do so by Cetec ERP, in writing (e.g., through an open source software license).

10.3 You may not (and you may not permit anyone else to) use Cetec for commercial purposes, defined as any case where users of the compliance testing by Cetec must pay to use such compliance testing. This prohibition includes pay-per-use, pay-per-access, subscription Software, or licensed software sales. Commercial entities may use Cetec for non-commercial use.

10.4 Unless Cetec ERP has given you specific written permission to do so (e.g., through an open source software license), you may not assign (or grant a sub-license of) your rights to use the Software, grant a security interest in or over your rights to use the Software, or otherwise transfer any part of your rights to use the Software.

10.5 Use, reproduction and distribution of components of the Software released under an open source software license are

governed solely by the terms of that open source software license.

10.6 In the event that the following events occur (referred to as "Release Events" below), existing license holders of the Software are granted a permanent license to use and modify the Software. Release Events are as follows:

- Cetec ERP Inc. ceases to exist to support and service the software.
- Rights to license the software may not be acquired through an entity related to Cetec ERP through merger, acquisition, or other agreement which transferred ownership of the Software.
- Neither Brent Barton, Taylor Wagen, Jordan Jolly, nor any other capable agents who were with Cetec ERP at the point Cetec ERP ceased to be able to support and service the Software are able and willing to support and service the software.

10.7 Cetec ERP Inc. provides the following optional methods for ensuring continued customer access to customer data (e.g. customer data, vendor data, inventory data, sales history data, etc.):

- A monthly process by which the customer may utilize Cetec's export features to export various customer data in order to export data to .csv or .xls spreadsheet file formats, and save those files to customer's own internal servers or third-party servers.
- Optional \$50/month service for nightly push of customer data and Cetec source code to customer internal server or third-party backup platform.
- If a skilled former Cetec ERP employee is available, contract with said employee for data export and delivery.

## 11. Content license from you

11.1 Cetec ERP claims no ownership or control over any Content (e.g., source code) written by you to be used with the Software. You retain copyright and any other rights you already hold in this code, and you are responsible for protecting those rights, as appropriate.

11.2 If you choose to submit your Content to Cetec ERP, you give Cetec ERP a worldwide, royalty-free, and non-exclusive license to reproduce, adapt, modify, translate, publish, publicly perform, publicly display and distribute this Content.

11.3 You agree that Cetec ERP, in its sole discretion, may use your trade names, trademarks, service marks, logos, domain names and other distinctive brand features in presentations, marketing materials, customer lists, financial reports and Web site listings (including links to your Website) for the purpose of advertising or publicizing your use of the Software.

## 12. Software updates

12.1 The Software which you use may automatically download and install updates from time to time from Cetec ERP. These updates are designed to improve, enhance and further develop the Software and may take the form of bug fixes, enhanced functions, new software modules and completely new versions. You agree to receive such updates (and permit Cetec ERP to deliver these to you) as part of your use of the Software.

## 13. Ending your relationship with Cetec ERP

13.1 The Terms will continue to apply until terminated by either you or Cetec ERP as set out below.

13.2 You may terminate your legal agreement with Cetec ERP by discontinuing your use of the Software at any time.

13.3 Cetec ERP may, at any time, terminate its legal agreement with you if:

(A) you have breached any provision of the Terms (or have acted in manner which clearly shows that you do not intend to, or are unable to comply with the provisions of the Terms); or

(B) Cetec ERP is required to do so by law (for example, where the provision of the Software to you is, or becomes, unlawful);  
or

(C) the partner with whom Cetec ERP offered the Software to you has terminated its relationship with Cetec ERP or ceased to offer the Software to you; or

(D) Cetec ERP is transitioning to no longer providing the Software to users in the country in which you are resident or from which you use the service; or

(E) the provision of the Software to you by Cetec ERP is, in Cetec ERP's opinion, no longer commercially viable.

13.4 Nothing in this Section shall affect Cetec ERP's rights regarding provision of Software under Section 4 of the Terms.

13.5 When these Terms come to an end, all of the legal rights, obligations and liabilities that you and Cetec ERP have benefited from, been subject to (or which have accrued over time while the Terms have been in force) or which are expressed to continue indefinitely, shall be unaffected by this cessation, and the provisions of Sections 14, 15 and Paragraph 19.7 shall continue to apply to such rights, obligations and liabilities indefinitely.

#### 14. EXCLUSION OF WARRANTIES

14.1 NOTHING IN THESE TERMS, INCLUDING SECTIONS 14 AND 15, SHALL EXCLUDE OR LIMIT Cetec ERP'S WARRANTY OR LIABILITY FOR LOSSES WHICH MAY NOT BE LAWFULLY EXCLUDED OR LIMITED BY APPLICABLE LAW. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES OR CONDITIONS OR THE LIMITATION OR EXCLUSION OF LIABILITY FOR LOSS OR DAMAGE CAUSED BY NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF IMPLIED TERMS, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES. ACCORDINGLY, ONLY THE LIMITATIONS WHICH ARE LAWFUL IN YOUR JURISDICTION WILL APPLY TO YOU AND OUR LIABILITY WILL BE LIMITED TO THE MAXIMUM EXTENT PERMITTED BY LAW.

14.2 YOU EXPRESSLY UNDERSTAND AND AGREE THAT YOUR USE OF THE SOFTWARE IS AT YOUR SOLE RISK AND THAT THE SOFTWARE ARE PROVIDED "AS IS" AND "AS AVAILABLE."

14.3 IN PARTICULAR, Cetec ERP, ITS SUBSIDIARIES AND AFFILIATES, AND ITS LICENSORS DO NOT REPRESENT OR WARRANT TO YOU THAT:

(A) YOUR USE OF THE SOFTWARE WILL MEET YOUR REQUIREMENTS,

(B) YOUR USE OF THE SOFTWARE WILL BE UNINTERRUPTED, TIMELY, SECURE OR FREE FROM ERROR,

(C) ANY INFORMATION OBTAINED BY YOU AS A RESULT OF YOUR USE OF THE SOFTWARE WILL BE ACCURATE OR RELIABLE, AND

(D) THAT DEFECTS IN THE OPERATION OR FUNCTIONALITY OF ANY SOFTWARE PROVIDED TO YOU AS PART OF THE SOFTWARE WILL BE CORRECTED.

14.4 ANY MATERIAL DOWNLOADED OR OTHERWISE OBTAINED THROUGH THE USE OF THE SOFTWARE IS DONE AT YOUR OWN DISCRETION AND RISK AND THAT YOU WILL BE SOLELY RESPONSIBLE FOR ANY DAMAGE TO YOUR COMPUTER SYSTEM OR OTHER DEVICE OR LOSS OF DATA THAT RESULTS FROM THE DOWNLOAD OF ANY SUCH MATERIAL.

14.5 NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED BY YOU FROM Cetec ERP OR



THROUGH OR FROM THE SOFTWARE SHALL CREATE ANY WARRANTY NOT EXPRESSLY STATED IN THE TERMS.

14.6 Cetec ERP FURTHER EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

#### 15. LIMITATION OF LIABILITY; INDEMNIFICATION

15.1 SUBJECT TO OVERALL PROVISION IN PARAGRAPH 14.1 ABOVE, YOU EXPRESSLY UNDERSTAND AND AGREE THAT Cetec ERP, ITS SUBSIDIARIES AND AFFILIATES, AND ITS LICENSORS SHALL NOT BE LIABLE TO YOU FOR:

(A) ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL CONSEQUENTIAL OR EXEMPLARY DAMAGES WHICH MAY BE INCURRED BY YOU, HOWEVER CAUSED AND UNDER ANY THEORY OF LIABILITY. THIS SHALL INCLUDE, BUT NOT BE LIMITED TO, ANY LOSS OF PROFIT (WHETHER INCURRED DIRECTLY OR INDIRECTLY), ANY LOSS OF GOODWILL OR BUSINESS REPUTATION, ANY LOSS OF DATA SUFFERED, COST OF PROCUREMENT OF SUBSTITUTE GOODS OR SOFTWARE, OR OTHER INTANGIBLE LOSS;

(B) ANY LOSS OR DAMAGE WHICH MAY BE INCURRED BY YOU, INCLUDING BUT NOT LIMITED TO LOSS OR DAMAGE AS A RESULT OF:

(I) ANY RELIANCE PLACED BY YOU ON THE COMPLETENESS, ACCURACY OR EXISTENCE OF ANY ADVERTISING, OR AS A RESULT OF ANY RELATIONSHIP OR TRANSACTION BETWEEN YOU AND ANY ADVERTISER OR SPONSOR WHOSE ADVERTISING APPEARS ON THE SOFTWARE;

(II) ANY CHANGES WHICH Cetec ERP MAY MAKE TO THE SOFTWARE, OR FOR ANY PERMANENT OR TEMPORARY CESSATION IN THE PROVISION OF THE SOFTWARE (OR ANY FEATURES WITHIN THE SOFTWARE); (III) THE DELETION OF, CORRUPTION OF, OR FAILURE TO STORE, ANY CONTENT AND OTHER COMMUNICATIONS DATA MAINTAINED OR TRANSMITTED BY OR THROUGH YOUR USE OF THE SOFTWARE;

(III) YOUR FAILURE TO PROVIDE Cetec ERP WITH ACCURATE ACCOUNT INFORMATION; OR

(IV) YOUR FAILURE TO KEEP YOUR PASSWORD OR ACCOUNT DETAILS SECURE AND CONFIDENTIAL;

15.2 THE LIMITATIONS ON Cetec ERP'S LIABILITY TO YOU IN PARAGRAPH 14.1 ABOVE SHALL APPLY WHETHER OR NOT Cetec ERP HAS BEEN ADVISED OF OR SHOULD HAVE BEEN AWARE OF THE POSSIBILITY OF ANY SUCH LOSSES ARISING.

15.3 You agree to defend, indemnify and hold harmless Cetec ERP, its affiliates, licensors and service providers, and its and their respective officers, directors, employees, contractors, agents, licensors, suppliers, successors and assigns from and

against any claims, liabilities, damages, judgments, awards, losses, costs, expenses or fees (including reasonable attorneys' fees) arising out of or relating to your violation of these Terms of Use or your use of the SOFTWARE, including, but not limited to, your User Contributions, any use of the content, services and products other than as expressly authorized in these Terms of Use or your use of any information obtained from the SOFTWARE.

#### 16. Copyright and trade mark policies

16.1 It is Cetec ERP's policy to respond to notices of alleged copyright infringement that comply with applicable international intellectual property law (including, in the United States, the Digital Millennium Copyright Act) and to terminating the accounts of repeat infringers.

#### 17. Other content

17.1 The Software may include hyperlinks to other Web sites or content or resources. Cetec ERP may have no control over any Web sites or resources which are provided by companies or persons other than Cetec ERP.

17.2 You acknowledge and agree that Cetec ERP is not responsible for the availability of any such external sites or resources, and does not endorse any advertising, products or other materials on or available from such Web sites or resources.

17.3 You acknowledge and agree that Cetec ERP is not liable for any loss or damage which may be incurred by you as a result of the availability of those external sites or resources, or as a result of any reliance placed by you on the completeness, accuracy or existence of any advertising, products or other materials on, or available from, such Web sites or resources.

#### 18. Changes to the Terms

18.1 Cetec ERP may make changes to the Terms from time to time. When these changes are made, Cetec ERP will provide them to you at your request.

18.2 You understand and agree that if you use the Software after the date on which the Terms have changed, Cetec ERP will treat your use as acceptance of the updated Terms.

#### 19. General legal terms

19.1 Sometimes when you use the Software, you may (as a result of, or through your use of the Software) use a service or download a piece of software, or purchase goods, which are provided by another person or company. Your use of these other Software, software or goods may be subject to separate terms between you and the company or person concerned. If so, the Terms do not affect your legal relationship with these other companies or individuals.

19.2 The Terms constitute the whole legal agreement between you and Cetec ERP and govern your use of the Software (but

excluding any Software which Cetec ERP may provide to you under a separate written agreement), and completely replace any prior agreements between you and Cetec ERP in relation to the Software.

19.3 You agree that Cetec ERP may provide you with notices, including those regarding changes to the Terms, by email, regular mail, or postings on the Software.

19.4 You agree that if Cetec ERP does not exercise or enforce any legal right or remedy which is contained in the Terms (or which Cetec ERP has the benefit of under any applicable law), this will not be taken to be a formal waiver of Cetec ERP's rights and that those rights or remedies will still be available to Cetec ERP.

19.5 If any court of law, having the jurisdiction to decide on this matter, rules that any provision of these Terms is invalid, then that provision will be removed from the Terms without affecting the rest of the Terms. The remaining provisions of the Terms will continue to be valid and enforceable.

19.6 You acknowledge and agree that each member of the group of companies of which Cetec ERP is the parent shall be third party beneficiaries to the Terms and that such other companies shall be entitled to directly enforce, and rely upon, any provision of the Terms which confers a benefit on (or rights in favor of) them. Other than this, no other person or company shall be third party beneficiaries to the Terms.

19.7 The Terms, and your relationship with Cetec ERP under the Terms, shall be governed by the laws of the State of Texas without regard to its conflict of laws provisions. You and Cetec ERP agree to submit to the exclusive jurisdiction of the courts located within the county of Travis, Texas to resolve any legal matter arising from the Terms. Notwithstanding this, you agree that Cetec ERP shall still be allowed to apply for injunctive remedies (or an equivalent type of urgent legal relief) in any jurisdiction.
